



Guidance for Prospective Authors

I. SUBSTANTIVE GUIDANCE

A. General article requirements

1. Length

Each article should be between 5,000 and 12,000 words (including references and in conformity with the guidelines outlined below). In exceptional cases longer and shorter contributions may be considered.

2. Attribution

The name(s) of the author(s) will appear at the beginning of each article. Authors should provide a brief statement, giving details of their academic degree, institutional affiliation and position, email and postal address. This information will appear in a special section of each issue of the Journal.

In those instances where an article has more than one author, information should be supplied, where appropriate, about which section(s) within the article each author was responsible for contributing.

3. Citation

Clear, precise, and comprehensive citation is absolutely essential. A few examples of proper citation are provided below.

4. Language

The *Journal of Belarusian Studies* will publish articles written in either English or Belarusian. A summary must be provided in the other language. See below for further details.

II. STYLE CONVENTIONS

A. Word processing format

- Microsoft Word Office.

B. Margins

- top, bottom, left, right: 2.5 cm.
- header, footer: 1.25 cm.

No guttering.

C. Title and author of article

- Title of article: 14-point Times New Roman, bold, caps, centred, double line spacing below.
- Author of article: 12-point Times New Roman, centred, double line spacing below. [structure: first name + any initials + surname]

D. Text

The abstract should precede the actual text of the article.

- Font: 12-point Times New Roman, full justification, double line spacing, no superscripts except for footnote references.
- Section headings (where used): 12-point Times New Roman, bold, left aligned, double line spacing above, single line spacing below.
- Paragraph indentation (use tab): 1.25 cm, **except** at start of article, after section headings (where used) and block quotations, where there should be no indentation.
- Block all quotations more than 25 words long: 12-point, fully justified, indent left and right 1.25 cm. No quotation marks.
- Lists (bullet points, alphabetical, numerical) within the article: single line spacing within each point, double line spacing between each point, fully justified, indent left and right 1.25 cm.
- Quotation marks: use single curly quotation marks, with double curly quotes within where necessary. Commas and full stops should be placed within the quotation marks only at the end of a quotation that forms a complete sentence.

E. Footnotes

- Font: 12-point Times New Roman, single line spacing, fully justified.
- Spacing: 0.5 tab after footnote number.

F. Footer

- Page numbers: 11-point Times New Roman, centred within the footer.

G. References

- There will be an alphabetical list of references at the end of the article, 12-point Times New Roman, single-spaced, left aligned.

- List to be headed with the word *References*, italic, left-aligned, double-spaced above, single-spaced below.
- Where there is more than one work by an author, the entry/entries after the first should start with an em-dash followed by a comma, rather than repeat the author's name. The items should be listed in ascending order of year of publication.
- Where there is more than one work by an author produced in the same year, letters of the alphabet should be attached to the year of publication, for example 1999a, 1999b and so on. These letters should also appear in the in-line references. Such works should be listed alphabetically by the first word of the title (excluding the definite article).
- Where no author (or editor) can be ascertained for a specific work, the item should be listed under title.

Information on the structure of reference list entries is given below.

III SUMMARY OF ARTICLE STRUCTURE

- Title of the article: should be concise (2 lines maximum).
- Abstract of max 200 words. Abstracts should contain the main ideas, the innovatory aspects of the article, its goals and results.
- The body of the article.
- List of references, alphabetically ordered by author.

IV GUIDANCE ON STYLE

Referencing should be by the author-date inline system (sometimes known as the Harvard system).

References

[The principles outlined below apply equally to articles written in English and Belarusian. The working language in all reference lists is English: the names of authors and editors will be listed in English alphabetical order. Letters with diacritics, for example Ž, will always follow the corresponding letter without diacritic.]

Spelling

For articles in English, use either British or American spelling. The main aim is to strive for consistency within each article.

Quotations

Use single quotation marks, and double for quotations within quotations:
The press attaché reported that ‘Gorbachev simply replied “Enough!”’.

Always give sources (including page reference) of quotations.

Numerals

Spell out numerals from one to ninety-nine, and use figures for 100 and above (but keep ‘hundred’, ‘thousand’, ‘million’ and ‘billion’ as words if they appear as whole numbers, for example, ‘a thousand years ago’).

Use figures in percentages: 26 per cent.

Inclusive numerals give the last *two* digits, for example, 15–17, 123–25, 401–04.

Use commas in numerals containing more than three digits to distinguish them from years: 1,914.

Dates

Use the style 9 June 1999. Add (OS) if Old Style. BCE and CE should be used instead of BC and AD.

Abbreviations

Use a full stop only if the last letter is not the last letter of the word, for example ‘Dr’, ‘St’, ‘vols’, *but* ‘Co.’, ‘p.’, ‘vol.’. Note also ‘no.’ *and* ‘nos.’ (both have stops).

Do not use stops in the names of institutions, countries, books, journals, academic degrees and so on. For example, USA, CIS, USSR, UN, BBC, *JBS*, *OED*, PhD.

Use ‘for example’ rather than e.g., ‘and so on’ rather than etc. and ‘that is’ rather than ‘i.e.’.

Transliteration

Belarusian placenames and personal names are to be transliterated by the system set out at http://unstats.un.org/unsd/geoinfo/UNGEGN/docs/10th-uncsgn-docs/crp/E_CONF.101_CRP2_The%20Roman%20alphabet%20transliteration.pdf (The Roman alphabet transliteration of Belarusian geographical names).

Where alternate forms exist for certain Belarusian placenames (for example Minsk/Miensk, Hrodna/Horadnia), the form currently in use in the Republic of Belarus is to be preferred. For rendering placenames in Ukraine, use the governmentally preferred forms, for example Kyiv, Odesa.

Transliterating Cyrillic in languages other than Belarusian: for Russian use the Library of Congress system (<http://www.lcweb.loc.gov/catdir/cpso/romanization/russian.pdf>), modified by

omitting the ligatures over ‘ts’, ‘iu’ and ‘ia’, removing the breve over the ‘i’ for й, and rendering the letter ‘ě’ as ‘io’. For Ukrainian use <http://www.lcweb.loc.gov/catdir/cpso/romanization/ukrainia.pdf>, with modifications similar to those for Russian, with the addition of ‘yi’ for ĭ.
